Course requirements: Participation in Discussion: Students are expected to read assigned readings and to participate actively in every session. Presentations: The students are required to prepare a short presentation that would serve as a springboard to the following discussion. In order to allow all students to actively participate in discussions after presentations, each student prepare a written handout beforehand and send it to students' email account at least two days before seminar. Evaluation: The final grade will be based on participation in class discussion (20%), presentation in the field of constitutional law (40%) and presentation in the field of criminal law (40%). A/1 = 91 – 100 %; B/1,5 = 81 – 90 %; C/2 = 73 – 80 %; D/2,5 = 66 – 72 %; E/3 = 61 – 65 %; FX = 0 – 60 %	
Learning outcomes: Students will get deeper knowledge from the philosophical and justice issues implicated by the study of differing constitutional regimes and regimes of criminal law. The course is organized around themes which are important in all jurisdictions: legitimacy, the role of the courts and the aims of constitutional democracy or impact of globalization. The main aim is to introduce key debates in constitutional theory and theory of criminal law.	
Class syllabus: 1. Introduction and basic instructions, concept and importance of comparative constitutional law 2. Nature, development and concept of constitutionalism, the process of amending the constitution, principle of legitimacy 3. Referendum as a form of direct democracy, pros and cons 4. Legislative power in comparative perspective 5. Executive power and head of state in comparative perspective 6. Constitutional courts in comparative perspective 7. Role of political parties, political extremism 8. Basic principles of criminal law as a field of public law 9. State criminal policy and tools of its implementation, rcrimnal offense - offender - state, Basic principles of criminal liability 10. Criminal Code as a basic source of criminal law, its scope and systematics
