General development of the Ancient Greek and then Roman sculpture, painting and pottery with characteristics of particular periods. Basic typology of ancient monuments and their significance in the context of the general history of art. Interpretation of the ancient art and culture in chronological structure from the beginning of Greek culture, protogeometric and geometric expression, to the specifics of archaic art. The "Greek miracle" – classical art of the 5th century BC. with an emphasis on sculpture and his masters, followed by the evolution of art in the 4th century BC. and by forms of artistic expression of the Hellenistic period. The second half of the course is devoted to a review of Roman art in similar thematic circles - the Etruscans and the roots of the Roman art expression, the portrait in the context of the art of the Roman Republic, the art of Augustus era, the Julio-Claudian dynasty, the art of the Flavians, the emperors Antonius Pius and the art of the 2nd century, Septimius Severus. Finally the Roman art of the 3rd century civil war and from the Tetrarchy to the Constantine.
