The student knows the fundamental terms connected with the main topic, as well as key representatives of major religious and philosophical schools, and has acquired adequate knowledge of sacral architecture, rituals and major deities of the Greek pantheon.

## Class syllabus:

- 1. Basic terms of the Greek religion. Development of Ancient religious studies.
- 2. Characteristic of Ancient Greek religion and representatives of various religious streams.
- 3. Basic religious ideas in Minoan and Mycenaean civilizations.
- 4. Major deities, religious rituals and funerals against the background of Homeric epics.
- 5. Ancient Greek ideas about the afterlife.
- 6. Religion of archaic Greece Hesiod and the origin of the gods.
- 7. Divination and therapeutic cults, magic.
- 8. Alternative cults, Orphics and Pythagoreans, mystery cults.
- 9. Sacred space temenos, temple, cult image and priests.

- 10. Sacred time calendar and holidays.
- 11. Religious life in classical Athens, reflections of religion in theatrical plays.
- 12. Twilight of the Greek religion in the time of Hellenism, the influence of Judaism and other ancient religions.

Theories of meaning (TM): extensional vs. intensional TM; the de dicto and de re substitution of expressions; logical vs. linguistic synonymy of expressions. Hyperintentional TM (epistemic and doxastic attitudes; types of contexts) and structuration of meanings of expressions - meaning of an expression as a structured procedure. 4. Interaction of logical operators and vectors of condition (and its

facticity or irreality), time and relevance (factual, hypothetical and counterfactual conditionals; deductive and abductive predication and retrodiction). 5. Violation of LS principles: idioms, metaphors, oxymorons, privative modifiers. Distortion of the validity of LS principles in condensed text: sentence elision (entymeme), word and phrase elision, intra-textual referencing; rules for the formation of elisions and references, and rules for the reconstruction of condensed and unconstrained texts. Argumentation and discussion in practice: deductive, abductive, persuasive, heuristic. Reasoning versus explanation.

## **Learning outcomes:**

At the end of the course, students have deep knowledge of the relations between the notions nation-state, national majority-minority, and state-minority at the background of the political and constitutional developments after 1918 in our territory, taking into account the Central European context. They are able to distinguish and hierarchize the key terms and concepts of the 20th century in the field, including nationalism. They are well familiar with the most influential figures of Slovak and Czech politics in relation to the key concepts of nation - minority - state.

- 1. Introduction to the issue. Key terms and concepts (nation, minority, state, nationalism). Outlining the problems in question.
- 2. The national and constitutional consequences of the disintegration of Austria-Hungary and the establishment of Czechoslovakia for the different nations.
- 3. Slovak nationalism and its development in the 20th century.
- 4. The development of the notion of Slovak statehood in the 20th century

- 5. Czechoslovakism, Czech-Slovak statehood and why this project did not succeed.
- 6. Development of the situation of minorities in Slovakia (and Czechoslovakia) in the 20th century
- 7. The development of nationalism among the Hungarian minority in Slovakia in the 20th century
- 8. The Slovak majority and the national minorities in the 20th century.
- 9. Comparing the development of the different segments (national, state law and minority) in the countries of Central Europe.
- 10. National and state symbols, myths and stereotypes in the context of Slovakia, Czecho-Slovakia and Central Europe.
- 11. Influential personalities of Slovak and Czech politics and their role in the researched issues. The phenomenon of the "founding father of the country."
- 12. Final discussion and conclusions.

## **Learning outcomes:**

After successfully completing the course, students have knowledge of the gender aspects of science, an overview of the position of women in science from both historical and contemporary perspectives. They understand basic feminist epistemological concepts and orientations and are able to apply them to current issues related to the underrepresentation of women in science and research, the glass ceiling phenomenon and the leaky pipeline. They understand the issue of gender dimensions of science in its various aspects and levels. They are able to apply a gender perspective in own research.
