<b>Course requirements:</b> Conditions for passing the course: The course consists of 10 active participations in the class, 10 weekly assignments, 1 pre-registration protocol and 1 ethical approval for research proposal, based on thorough understanding of the required reading. Students are expected to read weekly required readings and apply them to their dissertation projects. The necessary precondition for an active class participation is familiarity with required reading. Students are expected to provide feedback to their colleagues' applications of quantitative methods to dissertation projects. Students are expected to prepare assignments during the semester, in which they will present and discuss weekly topics concerning surveys, experiments, and quantitative content analysis related to their dissertation projects. In the examination period, students are expected to submit an AsPredicted pre-registration protocol (without the analytical plan sections) about surveys, experiments, or quantitative content analysis related to their dissertation projects. In the examination period, students are also expected to submit an ethical approval for research proposal about surveys, experiments, or quantitative content analysis related to their dissertation projects. The proposal should detail in a concise way the purpose of their investigation and procedures, anticipated risk and potential benefits to participants, steps taken to protect the participants, and manner of obtaining participants. <b>Learning outcomes:</b>	

Students will learn how to design, conduct and report surveys, experiments, and quantitative content analysis, how to pre-register their research design, and comply with ethical standards of political science research. The course is practically oriented – applying quantitative research methods to students' dissertation projects will enable them to gain a hands-on experience with exercising rigorous quantitative methodological standards.
