Learning outcomes: The aim of the Teacher Training in Psychology 1 is to support the professional vision of students of supplementary pedagogical studies/teaching. After completing the course, the student will know and be able to orient themselves in school documentation, will understand and be able to describe educational phenomena (elements of communication in a learning group, inter-individual differences of pupils, phenomena of learning group dynamics), and identify individual goals, methods, forms and phases of the teaching process. He/she will be able to make a record of the observation of the lesson.
