They are able to identify changing cultural patterns related to sexuality and sexual behavior - the so-called sexual scripts and know the processes that make sexuality the subject of politics in human history in an effort to control and regulate it. Upon successful completion of the course, students also know and are able to identify the main thematic areas related to love and intimacy or sexual identities. At the end of the course, students know how to use selected sociological terms and concepts and have adopted a sociological approach to their grasp and cognition. The acquired knowledge is able to theoretically and empirically investigate the above phenomena and social facts.
