An inherent complement to the defense of the dissertation is the formulation of primary scientific hypotheses, which, subsequently, through the implementation of a critical and systematic analysis, or other adequate scientific methods of research, results in a scientific output - of a confirmatory or contradictory nature. The defense of the dissertation finalizes the process of creating the potential to transform the research conclusions in the legislative practice of commercial and financial law. As a member of a scientific team, a doctoral student is eligible to participate in research on cross-disciplinary problems of several related fields of study. With his personal scientific contribution, he intervenes and shapes the further development of the science of commercial and financial law on a national, partial and international scale.</p>
