Learning outcomes: The student will master knowledge from the development of human rights; from the history of criminal and civil law in the 20th century in a liberal, totalitarian, social and legal state. In terms of content, the subject culminates in the creation of the Slovak Republic as a new subject of international law. The results of the education specifically include: - mastery (at the level of verbal and written presentation) of legal terminology and the ability to use its dictionary to describe the development of institutes, provisions of constitutional, international, civil and criminal law in the Czechoslovak state between 1919 and 1993; - the ability to analyze and interpret a historical legal text in its wider social context.	
Class syllabus: 1. International and constitutional aspects of the creation of Czechoslovakia with the Slovak nation and Slovakia as its integral part. 2. Development of the constitutional, administrative, civil and criminal law of Czechoslovakia (up to 1938, in 1945 – 1992). 3. Legal and political continuity of Czechoslovakia after Munich (1938), the establishment of the Protectorate and the declaration of the Slovak State. Wartime Slovak State – constitution, legal order, racial legislation; constitutional and international non-existence of the factual situation. 4. The Slovak National Council in the Slovak National Uprising, the "constitution" of Slovak national statehood and the new Czechoslovakia, the state of the Czech and Slovak nations on the principle of equality (1945); concrete manifestations of state law enshrining this principle (Prague Agreements, Constitution of May 9 (1948), Constitution of the Czechoslovakia (1960) and Constitutional Act on the Czechoslovak Federation (No. 143/1968 Coll.).	

5. Renewed or legally continuously existing Czechoslovakia; (1945 – 1948) people's democratic social system and state regime; international treaty of alliance with the USSR; Czechoslovakia in a geopolitically bipolarized world, the Cold War; the threat of a nuclear world war – Stalin's Sovietization of Czechoslovakia; forms and methods of applying the class-oppressive function of the state as a dictatorship of the proletariat (judicial and administrative and legal terror (1948 – 1954, respectively 1956; criticism of the cult of personality (1956 to 1961), de-Stalinization; the project of democratic socialism (until 1968 to 1969); so-called normalization (restoration of the class-political nature and functions of the state) (1970 – 1983); period of reconstruction; fall (implosion) of the real-socialist state regimes of the Warsaw Pact. 6. Unification of the Czechoslovak legal order (1949-1950). Second period of codification of legal branches (1960/1961 to 1964), criminal law (substantive and procedural); civil material and procedural; labor law, economic law. 7. November 1989, the development of constitutional law in 1989-1992; – rule of law; social and neoliberal orientation. Redress of wrongs. Restitution, privatization. Amendment of the codes of legal branches, transformation of the legal order into a post-real socialist, market capitalist one. 8. Constitution of the Slovak Republic from 1992; institutes and provisions of Slovak constitutional law. Amendment to the Constitution and entry of the Slovak Republic into the European Union (delegated part of sovereignty, fragmentary or shared sovereignty).
