It introduces law as a normative system in general, distinguishing it from other non-legal systems. Special attention is paid to the issue of sources of law (including their hierarchy in the Slovak Republic), the topic of legal norms and their internal structure, implementation and application of law, interpretation of law, but last but not least the institute of responsibility in law in general. After completing the course, the student should not only acquire a comprehensive overview of the legal order and the system of law as such, but he/she should also be able to solve the first practical cases.
