The student will therefore deal with standard issues in an above-standard way, requiring work with all sources of legal information when solving practical assignments. In addition to the above, emphasis will also be placed on procedural acts within the proceedings before the court and the proceedings before the court as such. Therefore, with such practical demonstrations, the graduate will learn more about the skills necessary for the performance of the activities of a lawyer or judge in the field of civil and labor law.

The interdisciplinary nature of the course is also reflected in the student's ability to comprehensively solve practical cases, create legal submissions and legal arguments, which also fulfils the course objective of preparing the student for the requirements of application practice. The student will therefore deal with standard issues in a superior manner requiring work with all sources of legal information when solving practical assignments.	
Class syllabus: In dealing with practical assignments, submissions and analyses, the course will focus mainly on the following topics, which will be examined mainly from a criminal law perspective, while taking into account aspects of financial law, economic law and economics: <ul style="list-style-type: none"> - Misuse of tax law norms, - violations in the financial market sector: banks, insurance companies, securities dealers, etc, - unlawful activities in the field of monetary law, foreign exchange law, customs law, - financial control, - bankruptcy or imminent bankruptcy of an entrepreneur, a company in crisis, bankruptcy, insolvency proceedings and related machinations, - abuse of market position - competition, unfair competition, - violation of legislation on public procurement, public auction, 	

- unauthorised trade business.
