The course focuses on understanding the manager's personality and its impact on management and decision-making, developing interpersonal and organizational communication, applying emotional and cultural intelligence in the workplace, recognizing the importance of the work environment for employee performance and satisfaction, and strengthening the well-being of managers as a prerequisite for long-term performance, resilience, and professional growth. Students will develop the ability to analyze psychological aspects of managerial behavior, identify workplace problems, and propose solutions that support effective collaboration, motivation, and a healthy work environment.	
Class syllabus: Course Outline 1. Introduction – organizational information on course requirements, assignments, etc. 2. Psychology and its Use in Organizations – what is useful to know about psychology, structure of psychological sciences, methods of psychological research. 3. Mental Phenomena and Processes – cognitive processes, techniques for supporting creative solutions, the process of perception and its significance in interpersonal interactions, perceptual barriers, self-perception and self-awareness. 4. Personality – personality theories, personality traits. 5. Manager's Personality Qualities – requirements for an effective manager, manager in a multicultural organizational environment.	

6. Communication Skills of a Successful Manager – interpersonal communication, communication in a multicultural environment, how to improve interpersonal communication, leading meetings, presentation skills, assertive behavior.
7. Emotional and Cultural Intelligence – manager's character and their emotional intelligence (EQ) and cultural intelligence.
