The student is able to identify, find and interpret relevant legislation, jurisprudence, legal doctrine and other legal information, and based on this, make informed decisions that also take into account social, scientific and ethical aspects within international, EU energy law and energy law of selected states; he also masters the methods of interpretation and application of legal norms and ascertainment of the facts.
