The intention is to prepare the doctoral candidate for the debate on the written thesis for the dissertation examination and for the following part of the dissertation examination, in which the doctoral candidate is to demonstrate theoretical knowledge and a comprehensive body of knowledge in the field of commercial and financial law.	
Class syllabus: The student, by completing the relevant theses and preparing for the examination in his/her field of study, will gain knowledge related to the solution of challenging theoretical-application questions forming the authorial focus of his/her future dissertation.
