<b>Learning outcomes:</b> Knowledge: Students will acquire a deep interdisciplinary overview that connects civil law with other areas of the legal system (e.g., constitutional, administrative, commercial, and international law), taking into account the influence of European and international law in solving practical problems in civil law. Skills: The interdisciplinary nature of the course, i.e., the combination of substantive and procedural law, is also reflected in the student's ability to comprehensively solve practical cases, draft legal submissions, and argue legal cases after completing the course, thereby fulfilling the course's objective of preparing students for the requirements of professional practice. Students will therefore address standard issues in an above-standard manner, requiring them to work with all sources of legal information when solving practical assignments. Students are able to independently analyze complex legal situations and develop qualified proposals for their resolution, effectively applying legislation, case law, and legal doctrine. They are able to combine substantive and procedural aspects in a specific case (e.g., contractual relationships and their judicial enforcement), propose practical solutions that also take into account the strategy of conducting a dispute or alternative solutions. They are skilled at communicating with clients and other participants in legal relationships or civil proceedings, understand their needs, and are able to draft the necessary documents, lawsuits, proposals, contracts, legal analyses, and opinions in a form that is understandable to the lay public. They are able to make qualified decisions even with incomplete or	

conflicting information, with an emphasis on ethical and social responsibility. They know how to argue legally and in terms of values, taking into account the broader implications of legal solutions. Responsibility and independence: Students are able to competently apply the relevant legal norms of civil law, case law, and legal doctrine in interdisciplinary contexts to complex and complicated case studies. They are prepared to immediately produce high-quality legal outputs in the public administration, judiciary, and private sectors related to the provision of legal services, with an emphasis on precision, practicality, and social responsibility. They are able to critically reflect on ethical dilemmas that arise, for example, in conflicts of interest, confidentiality protection, representation of vulnerable clients, or balancing the legal and moral aspects of a case. They are able to justify their decisions credibly and convincingly, with an emphasis on legal correctness and humanity.

Teaching that also takes into account the requirements of practical application in the areas of the judiciary, public prosecution, and legal professions, which are supervised by the Ministry of Justice of the Slovak Republic.

<b>Learning outcomes:</b> A) Knowledge: After completing the course, students will have interdisciplinary knowledge and a comprehensive view of selected topics from the perspective of criminal law, financial law, and economic law, while taking economic aspects into account. Students will be able to identify and utilize synergies between different areas of law in order to find optimal solutions. B) Skills: Students are able to comprehensively solve practical cases with interdisciplinary overlap (using interdisciplinary connections and linking all sources of legal information) and have specialized skills for independent and qualified resolution of legal problems. They are able to draft legal submissions and argue legally, thereby fulfilling the objective of the course, which is to prepare students for the requirements of practical application. C) Responsibility and independence: Students are qualified to independently draft high-quality and comprehensive legal outputs and submissions in the areas of public administration, justice, or the private sector, all while critically evaluating the relevance of legal and non-legal information. They are able to independently resolve legal issues and propose optimal procedures and solutions. Teaching that also takes into account the requirements of practical application in the areas of the judiciary, public prosecution, and legal professions, which are supervised by the Ministry of Justice of the Slovak Republic.	
<b>Class syllabus:</b>	

In dealing with practical assignments, submissions and analyses, the course will focus mainly on the following topics, which will be examined mainly from a criminal law perspective, while taking into account aspects of financial law, economic law and economics:

- Misuse of tax law norms,
- violations in the financial market sector: banks, insurance companies, securities dealers, etc,
- unlawful activities in the field of monetary law, foreign exchange law, customs law,
- financial control,
- bankruptcy or imminent bankruptcy of an entrepreneur, a company in crisis, bankruptcy, insolvency proceedings and related machinations,
- abuse of market position - competition, unfair competition,
- violation of legislation on public procurement, public auction,
- unauthorised trade business.
